Johns Manville International, Inc. ("Johns Manville") warrants to the owner of the buildings that, its **Expansion Joint Covers, Factory Produced Intersections or Terminations, and all Field Splices ("Expand-O-Flash® Products")** are free from manufacturing defects which will result in a leak, and that the Expand-O-Flash® Products will not deteriorate due to weathering so that they become incapable of performing their role in maintaining a watertight joint for a period of ten (10) years from the date of installation of the Expand-O-Flash Products providing they are installed, maintained and used in a manner consistent with Johns Manville specifications.

TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, JOHNS MANVILLE DISCLAIMS ANY IMPLIED WARRANTY OF MERCHANTABILITY

Extent of Johns Manville Liability

1. Repair or Replace Policy

During the 10-year period specified herein, if the Expand-O-Flash Products leak and upon investigation are found to contain manufacturing defects which resulted in a leak, you, as purchaser of the Expand-O-Flash Products will, at Johns Manville's election, receive prompt repairs to the materials, receive a resupply of the Expand-O-Flash Products at issue and the labor to install or a credit to be applied towards the purchase of replacement materials, including the installation labor. Notice of such a claim must be provided to Johns Manville within 30 days after discovery by the owner or the owner's agent of a leak.

2. Liability Limited to Original Installed Cost

During the 10-year period from the registered date of completion, if manufacturing defects cause a leak requiring the repair or replacement of any portion of the Expand-O-Flash Products, Johns Manville will repair or replace such material provided that Johns Manville's liability for the replacement of such material shall not result in costs to Johns Manville which exceed the original installed cost of the Expand-O-Flash Products.

AND THE WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE. THE LIMITED WARRANTY DESCRIBED HEREIN IS YOUR EXCLUSIVE WARRANTY FROM JOHNS MANVILLE AND REPRESENTS THE EXCLUSIVE REMEDY AVAILABLE TO ANY PURCHASER OF THE EXPAND-O-FLASH PRODUCTS. JOHNS MANVILLE MAKES NO OTHER REPRESENTATION OR WARRANTY OF ANY KIND OTHER THAN THAT STATED HEREIN. THIS LIMITED WARRANTY MAY BE MODIFIED ONLY BY INCLUDING THE EXPAND-O-FLASH PRODUCTS IN A JOHNS MANVILLE ROOFING SYSTEM GUARANTEE, PROPERLY ISSUED BY JOHNS MANVILLE, OR SOME OTHER WRITTEN INSTRUMENT SIGNED BY AN AUTHORIZED JOHNS MANVILLE REPRESENTATIVE AND NO RETAILER, CONTRACTOR OR DISTRIBUTOR IS AUTHORIZED TO ALTER THIS WARRANTY.

2. Resupply Policy

RESUPPLY SHALL MEAN FURNISHING FREE OF CHARGE (F.O.B. PLACE OF ORIGINAL PURCHASE) A NEW SHIPMENT OF THE EXPAND-O-FLASH PRODUCTS IN AMOUNTS SUFFICIENT TO REPLACE THAT PORTION OF THE EXPAND-O-FLASH PRODUCTS FOUND TO BE IMPROPERLY PERFORMING, PLUS THE LABOR TO INSTALL NEW PRODUCTS.

JOHNS MANVILLE SHALL NOT BE LIABLE FOR ANY INCIDENTAL, CONSEQUENTIAL OR OTHER DAMAGES SUCH AS DAMAGE TO THE STRUCTURE TO WHICH THE EXPAND-O-FLASH PRODUCTS ARE AFFIXED OR ITS CONTENTS; NOR SHALL JOHNS MANVILLE BE LIABLE FOR ANY DAMAGES WHICH ARE BASED ON NEGLIGENCE, BREACH OF WARRANTY, STRICT LIABILITY, OR ANY OTHER THEORY OTHER THAN THE EXCLUSIVE LIMITED LIABILITY SET FORTH ABOVE. INCIDENTAL AND CONSEQUENTIAL DAMAGES SHALL NOT BE RECOVERABLE EVEN IF THE RESUPPLY REMEDY PROVIDED HEREIN FAILS OF ITS PURPOSE.

Exclusions from Limited Warranty Coverage

This Repair/Replacement Warranty does not obligate Johns Manville to repair or replace the Expand-O-Flash Products for leaks resulting from:

1. Natural disasters including, but not limited to hail, hurricanes, lightning, windstorms and earthquakes;
2. Acts of negligence, misuse or abuse, vandalism or exposure of the Expand-O-Flash Products to damaging substances such as oils, solvents or other chemicals or to damaging conditions such as vermin or roof traffic;
3. Failure of the substrate whether mechanical, structural or otherwise, including but not limited to building movement, design defects or improper drainage (ponded water);

4. Defects or failure of materials and/or metal work used in any roof or building component not manufactured by Johns Manville;
5. Moisture entering the roof system through walls, copings, any other part of the building structure or surrounding materials;
6. Defects in any aspect of installation, workmanship or design, including, but not limited to failure of the installation to comply with Johns Manville specifications;
7. Any change or alteration in the building usage or to the Expand-O-Flash Products unless pre-approved in writing by Johns Manville.
