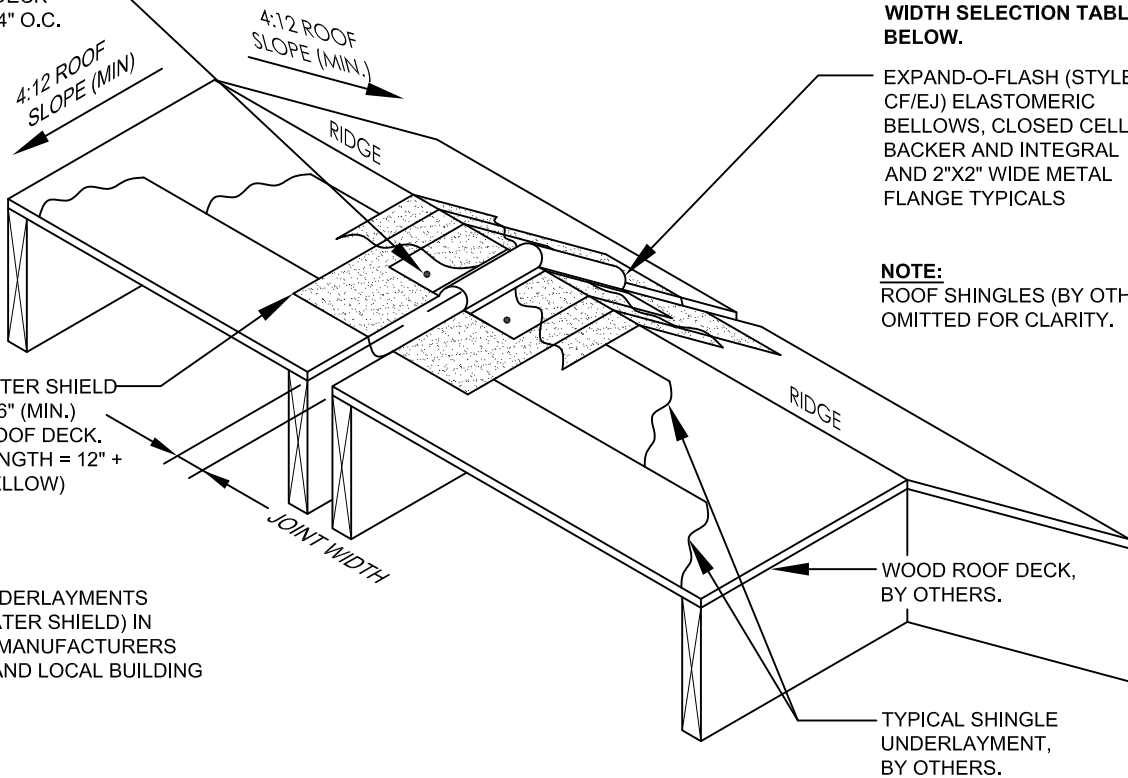


FASTEN EXPANSION JOINT
